### CONTEXT



#### Major external factors influencing NTD resource mobilisation in 2024

#### Year of elections

- Globally, more voters than ever in history will head to the polls this year, as at least **64 countries** (plus the European Union)—representing a combined population of about 49% of people in the world **are due to hold elections this year**
- In Africa alone, 18 countries Botswana, Comoros, Senegal, Ghana, Rwanda, Madagascar, Tunisia, Guinea Bissau, Namibia, South Sudan, South Africa, Mauritania, Mozambique, Somaliland, Mali, Cabo Verde, Chad, Mauritius
- 6 of the 10 largest bilateral donors that tend to dominate global funds, also go into elections in 2024 (UK, US, EU) and 2025 (Japan, Canada, Norway).
- WHO election of the new Regional Director for WHO AFRO
- This means new administrations, new Ministers, "zero-sum competition for a fixed pot of resources"



- The Pandemic Fund needs \$10billion annually, US\$2bn raised so far. Status of Pandemic Fund

Cost of living and stagnation/recession; Drops in ODA (including EU, Germany and France)
Reduction in funding going to Africa with OECD reporting that funding to SSA fell by over 7% in 2022 and is continuing to fall Amongst opportunities: Expansion of BRICS and Global South hosting G20 meetings

## WHAT DOES THIS MEAN FOR UNITING IN 2024?

#### Opportunities for 2024

- 1. Ensure we do not lose what we currently have donor countries sustain existing funding; position NTDs as a litmus test for equity and the leave no one behind agenda
- 2. Work to contribute towards the US\$160m fund balance for the 'Africa Free Fund' (RLMF 2.0), including the US\$50m target from domestic sources and use this as a catalyst for wider domestic resource mobilisation
- **3. Support resource mobilisation for specific packages -** e.g. SCH and STH implementation funding (WHO leading), Rabies PEP uptake by countries, PAED PZQ access and ESPEN
- **4. Spotlight NTD funding opportunities for countries within existing global funding mechanisms** e.g. GFATM, GFF, Pandemic Fund
- 5. Position NTDs as a flagship initiative of IDA21 in order to unlock substantial funding for national NTD masterplans
- 6. Showcase industry commitments as a lever for resource mobilisation
- 7. Take advantage of the shifting political powers to unlock South-South cooperation/funding for the longer-term e.g., taking advantage of the role of Brazil in G20 and the expanded BRICS membership (which includes UAE and Ethiopia for example)
- **8. Build demand for NTD interventions by affected countries -** including through work with youth, women leadership, parliamentarians and African traditional and customary leaders

#### **AU SUMMIT EVENT**

The Addis Ababa Call-to-Action: An Africa free of neglected tropical diseases



A high-level side event was convened at the 37th Ordinary Session of the Assembly of the African Union in Ethiopia to discuss the imperative of financially resourcing efforts to eliminate NTDs and subsequently, the Addis Ababa Call-to-Action was born, outlining several concrete steps for advancing NTD elimination efforts.











#### PROMOTING SUSTAINABILITY THROUGH RESOURCE MOBILISATION: FINANCIALLY RESOURCING AN AFRICA FREE OF NTDS BY ENDEMIC MEMBER STATES

#### Addis Ababa Call to Action

#### I. INTRODUCTION

- A. We, the African Union Member States and Development Partners convened in Addis Ababa, Ethiopia on the sidelines of the 37<sup>th</sup> Ordinary Session of the Assembly of the Heads of State and Government of the African Union to promote sustainability to ensure an Africafree of Neglected Tropical Diseases (NTDs).
- B. Recognise the heavy burden of NTDs on the people of Africa including the most vulnerable.
- C. Acknowledge the continued vulnerability of Africa's NTDs control, elimination, and eradication programmes due to heavy reliance on external funding.
- D. We recognize the important role of working with National Regulatory Authorities (NRAs), in creating an enabling regulatory environment for research, product development, and manufacturing of the medicines needed to eliminate NTDs. We further call upon the countries that have not yet ratified the AMA Treaty to expedite the ratification processes for all AU Member States to work together in ensuring access and safety of medicines.
- E. Recognize the commitment and strong country ownership of countries that have already eliminated specific NTDs including Togo, the first country in the world to be validated for eliminating four NTDs (Guinea worm disease, lymphatic filariasis, sleeping sickness, and trachoma) Mali and Benin (trachoma) in 2023, joining 18 other African Union Member States who have already eliminated at least one NTD and urge other countries to follow their example.
- F. Noting that as countries achieve validation for the elimination of NTDs as a public health concern, sustained investments in post-elimination surveillance and cross-border collaboration are crucial to prevent the re-emergence of previously eliminated NTDs.
- G. Note that the elimination of NTDs has the potential to reduce poverty across the continent. This encompasses poverty alleviation, the promotion of inclusive education, the advancement of gender equality, the reduction of disparities, the development of human capital, and the stimulation of economic growth.
- H. Acknowledge the significant role of the NRAs in facilitating the approval and registration of the remedies needed to eliminate NTDs and monitor their safety building on the ongoing efforts of the African Medicines Regulatory Harmonization (AMRH) and the AU-Smart Safety Surveillance (AU-3S).
- Acknowledge the Africa Centres for Disease Control and Prevention's (Africa CDC's)
  pivotal support in enhancing the capabilities of Member States and regional health
  systems to effectively prevent and manage high-burden diseases, including NTDs, by
  applying One Health and equity principles, and fostering local manufacturing in Africa
- J. Recognize the inclusion of the lifesaving Rabies post-exposure prophylaxis in the GAVI portfolio that countries can now apply for and the need for rapid adoption and deployment of the recently approved pediatric praziquantel, opening the way for countries to extend
